



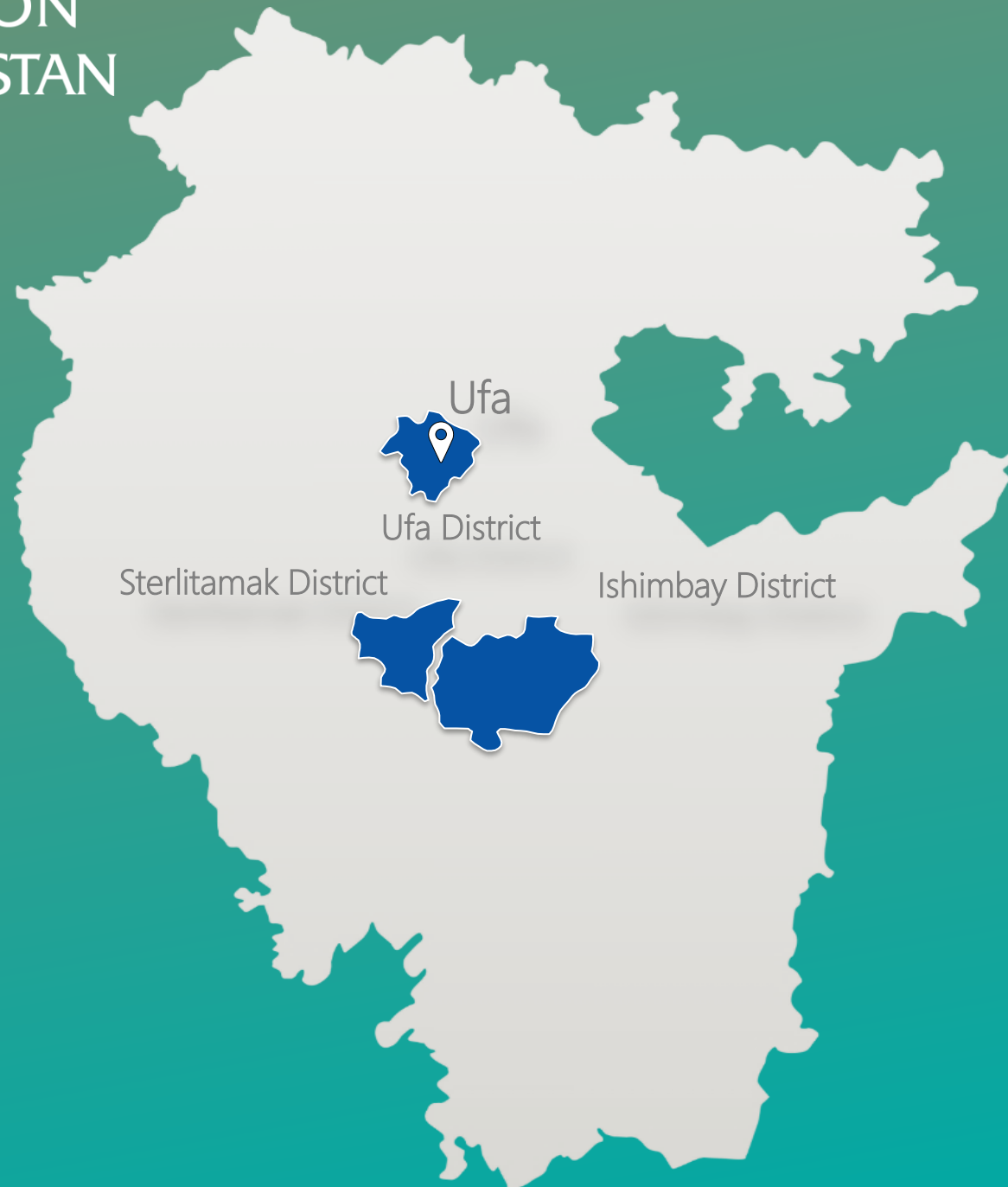

THE REPUBLIC OF BASHKORTOSTAN



The Republic of Bashkortostan is one of the leading industrial and agricultural regions of the Russian Federation, included in the list of key oil-producing regions of the country, and serves as a major hub for the chemical industry and mechanical engineering.



The region is among the top three leaders in the rating of industrial policy effectiveness in the Russian Federation.



The region ranks third in the National Investment Climate Assessment Rating among the regions of the Russian Federation for 2025.



SEZ «Alga» ranked third in the IX National Rating of Investment Attractiveness of SEZs in Russia. Since its establishment, SEZ «Alga» has been recognised twice as the most dynamically developing SEZ in Russia according to this rating. In 2023, it was awarded first place in the «Import Substitution» category, and in 2024 — in the «Stable Growth» category.



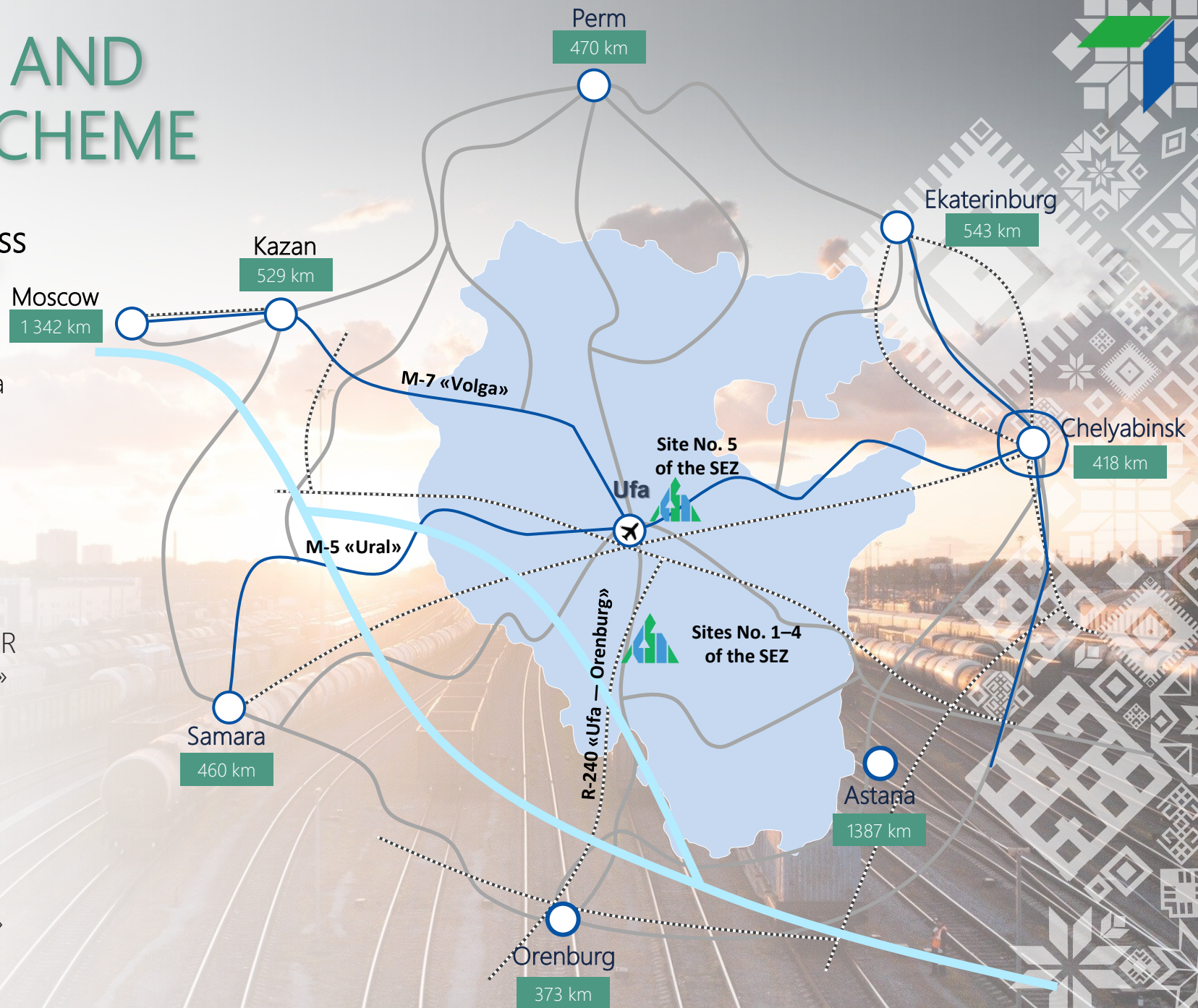


TRANSPORT AND LOGISTICS SCHEME

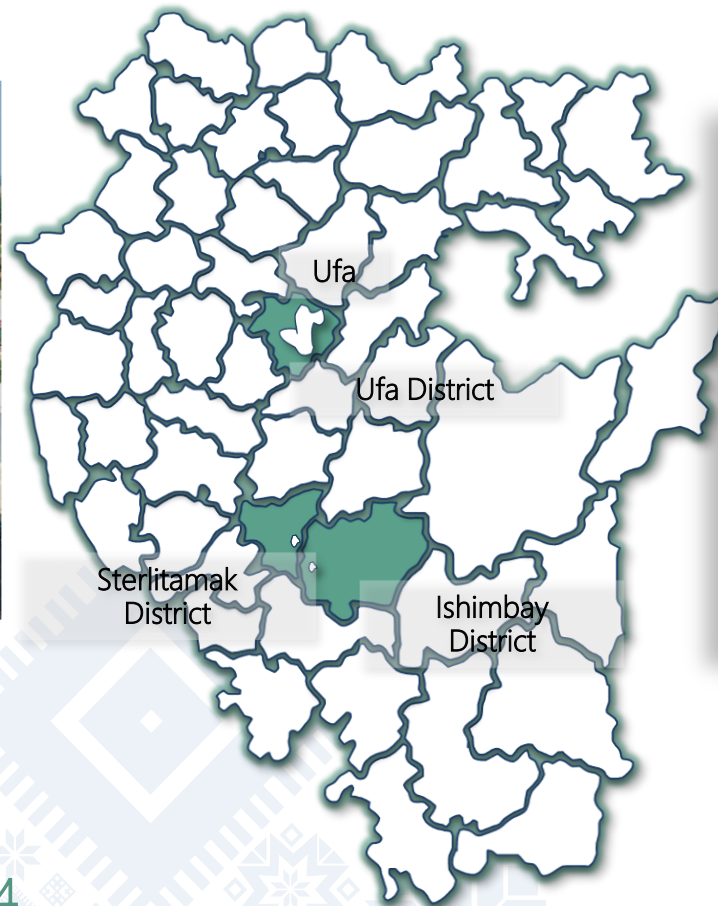

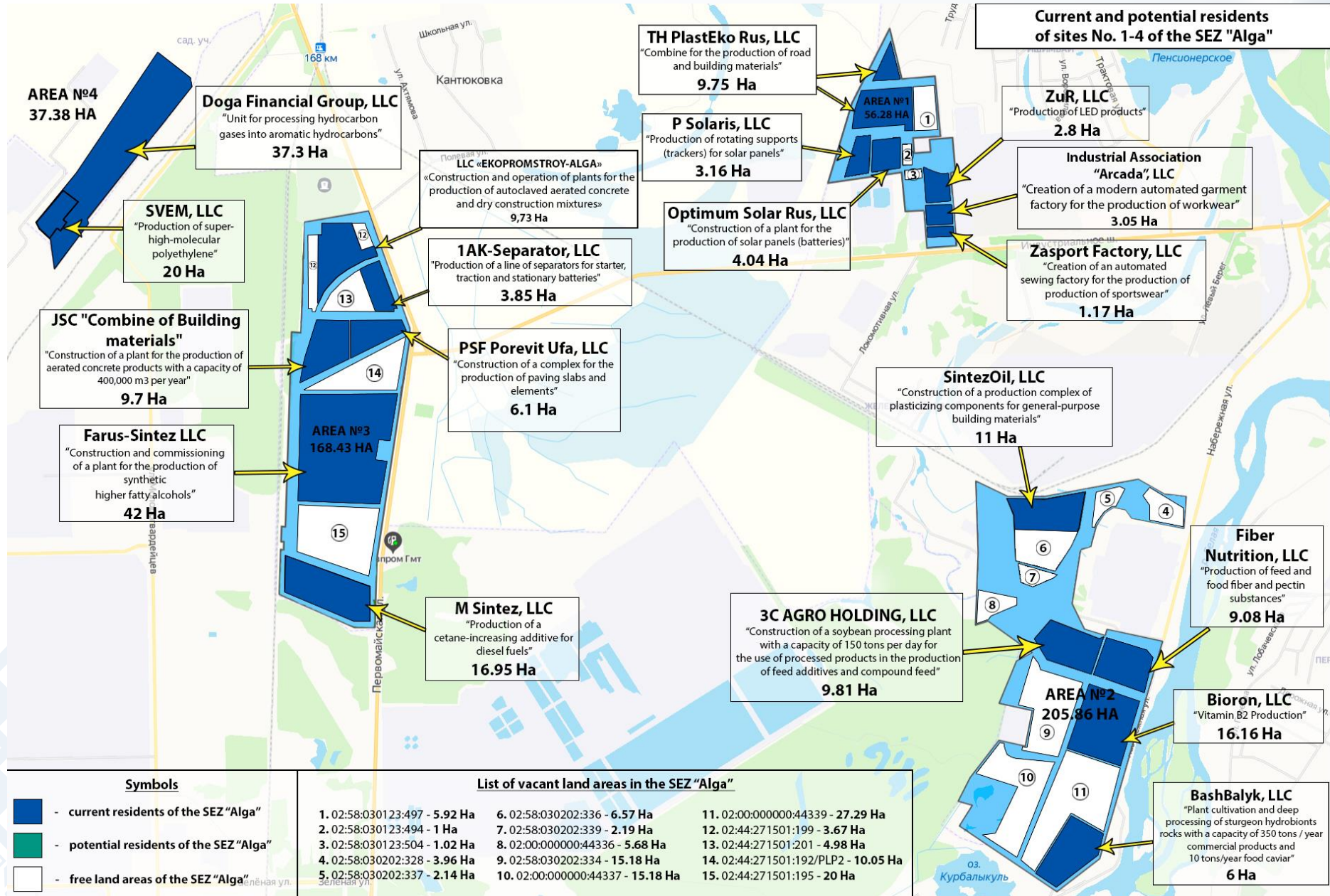

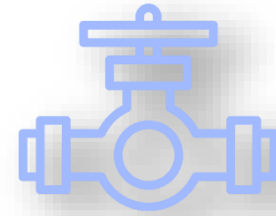

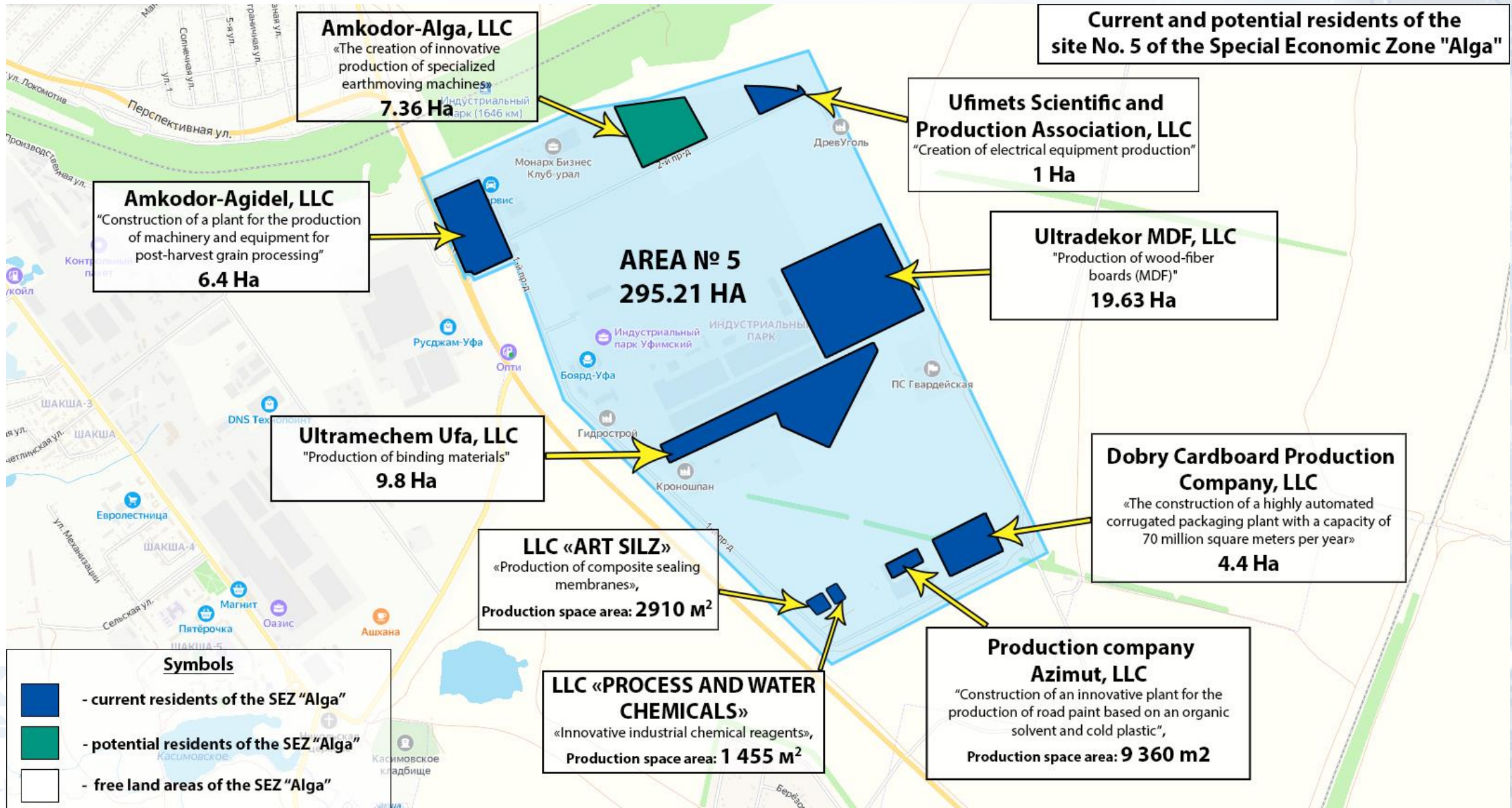

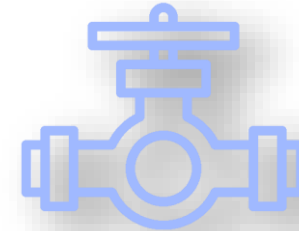

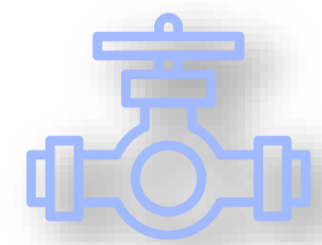

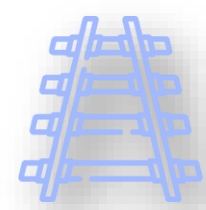

TAX INCENTIVES IN THE SEZ «ALGA»*



Type of incentive	Budget level	General regime	Incentives within the SEZ «Alga»
Corporate income tax	Federal budget	8 % (since 2025 to 2030) 7 % (since 2031)	2 %

Transport tax	Regional budget	10 - 250 RUB/h.p.	0 RUB/ h.p. for 10 years starting from the tax period in which the vehicle was registered, but not earlier than the date the organisation acquired SEZ resident status. Applies to: freight vehicles; buses; other self-propelled vehicles, machines and mechanisms with pneumatic or crawler tracks

* As of 1 April 2026, Federal Law No. 18-FZ of 11 February 2026 comes into force, introducing a new mechanism for granting tax incentives to residents of preferential regimes. The scope of incentives now directly depends on actual capital investments and R&D expenditures. The changes apply to new residents acquiring SEZ status after 1 April 2026. In the first three years after acquiring resident status, restrictions on the use of incentives do not apply.

*** for supplies within the free customs zone and to SEZ residents; also includes exemption from import duties and taxes on foreign equipment while it is located within the SEZ



OPERATION OF THE FREE CUSTOMS ZONE



Exemption from VAT and import duties on imported materials and raw materials processed within the SEZ territory

Exemption from import customs duties and taxes on foreign equipment during the period when such equipment is located within the SEZ territory

Exemption from VAT, as well as import and export duties on goods imported and sold within the territory of the Customs Union (Russian Federation, Belarus, Kazakhstan, Kyrgyzstan, Armenia)

Exemption from customs duties and VAT in case of production using foreign components and sale of finished products to the Customs Union countries

Payment of export duty only on manufactured goods recognised as Customs Union goods when exported beyond the Customs Union borders

No duties or VAT when reselling foreign goods beyond the Customs Union countries

Payment of export duty only when reselling Customs Union goods beyond the Customs Union borders

Exemption from customs duties and VAT when exporting goods recognised as foreign beyond the Customs Union borders



ADDITIONAL SUPPORT FOR SEZ RESIDENTS



ACCELERATED DEPRECIATION IN THE SEZ

The possibility of applying a special coefficient to the standard depreciation rate, but not exceeding 2, to own depreciable fixed assets (in accordance with subparagraph 3, paragraph 1, Article 259.3 of the Russian Tax Code)

LAND LEASE*

2% of the cadastral value of the land plot, with the possibility of applying a reduced coefficient for land lease up to 0.5**
(in accordance with the order of the Ministry of Economic Development of the Russian Federation № 313 dated 27.05.2024)

** regarding land plots owned by the state or municipal authorities;*

*** the established coefficients do not change for 5 years from the date of signing the lease agreement. After the specified period, the coefficient is set to 1, in accordance with the Order of the Ministry of Economic Development of Russia dated May 27, 2024, No. 313*



RESIDENCY IN A SPECIAL ECONOMIC ZONE



REQUIREMENTS TO SEZ RESIDENTS:

Business entity (excluding unitary enterprises).

Registration of a legal entity within the municipal formation where the SEZ is located

No branches or representative offices outside the SEZ

A signed agreement on conducting activities in the SEZ PPT «Alga» between: the resident; the Government of the Republic of Bashkortostan; the Development Corporation of the Republic of Bashkortostan.

Capital investments of at least RUB 120 million, including: at least RUB 80 million within the first 3 years.

ACTIVITIES PROHIBITED WITHIN THE SEZ:

Development of mineral deposits, except for: mineral waters; other natural therapeutic resources.

Production and processing of excisable goods, except for: production of passenger cars and motorcycles; production and processing of ethane, liquefied petroleum gases, molten steel; production of pharmaceutical ethanol, medicinal products; use of natural gas for ammonia production.

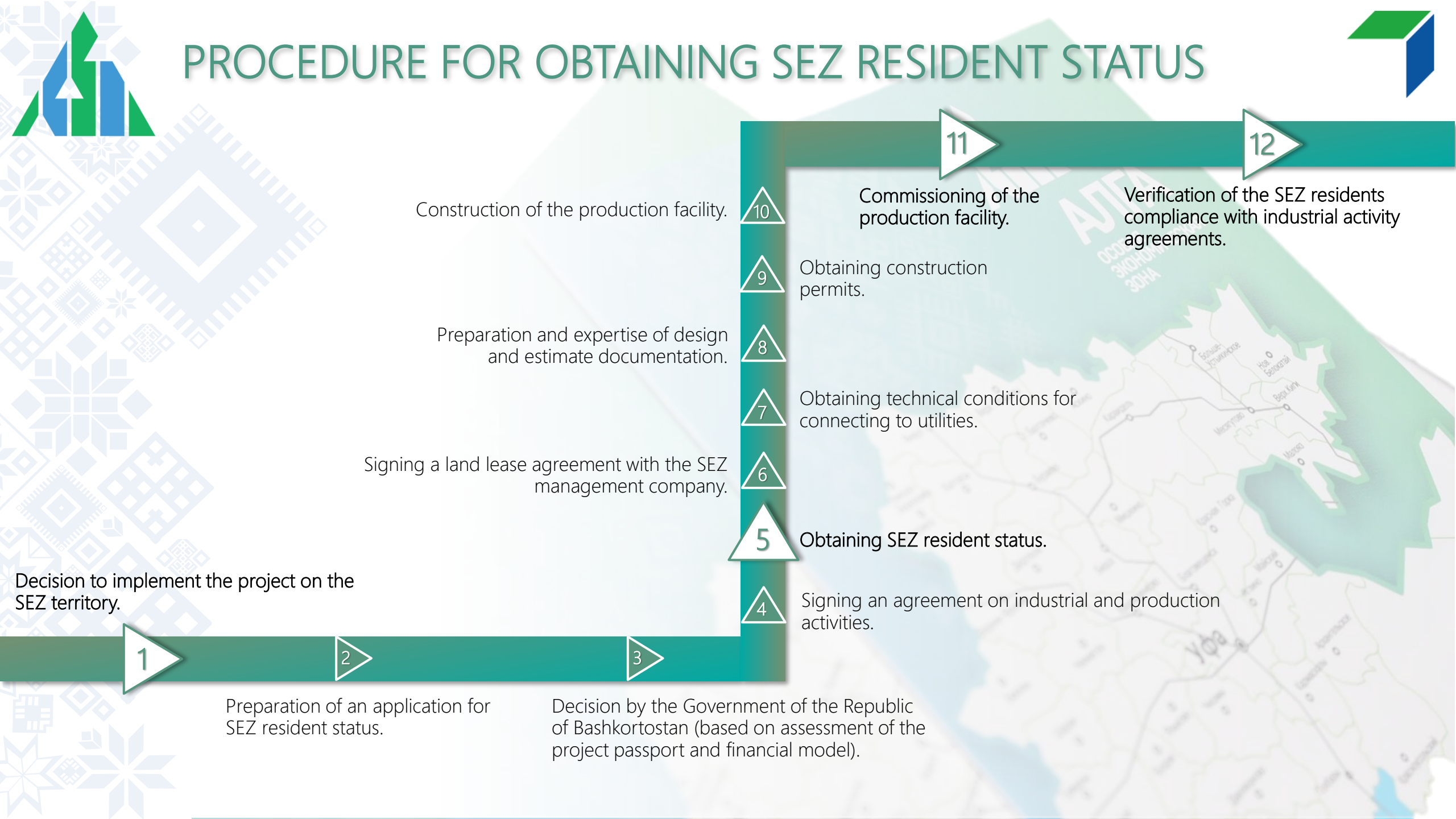
ALLOWED ACTIVITIES WITHIN THE SEZ:

Industrial and manufacturing activities: production and/or processing of goods (products) and their sale.

Technology and innovation activities: development of innovative activities to create and sell scientific and technical products; bringing products to industrial application; development of software products, data collection, processing, and transmission systems, distributed computing systems; provision of services for the implementation and maintenance of such products and systems.

Logistics activities: provision of services to ensure the transportation and warehousing of goods.
